



FIXED ASSET POLICY

1. Any item purchased or acquired that has a useful life of three years and costing over \$5000 will be capitalized.
2. The straight-line depreciation method will be utilized for capitalization purposes.
3. Any items costing under \$5,000 will be expensed to the year the item is acquired.
